Pharmacy Plan Creditable Coverage Notice

A message from Health Net Health Plan of Oregon, Inc. "Health Net"

Dear Valued Client,

At Health Net, we're committed to keeping you informed about important requirements related to your group health benefits. This letter provides you with key information about **Medicare Part D Creditable Coverage** for your **Health Net pharmacy plans**.

Employer Obligations Under Medicare Part D

Since 2006, Medicare has provided prescription drug coverage through the **Medicare Part D program**. Employers that offer prescription drug benefits to Medicare eligible employees, retirees, or their dependents are required to:

- **Determine whether the prescription drug coverage offered is considered Creditable Coverage.**
Creditable coverage is defined as coverage that is expected to pay, on average, at least as much as the standard Medicare Part D prescription drug benefit.
- **Provide annual notification to Medicare eligible individuals** regarding the status of their pharmacy coverage - specifying whether their coverage meets the standard for Creditable Coverage.
- **Submit an annual disclosure to the Centers for Medicare & Medicaid Services (CMS)** indicating the prescription drug plan's Creditable Coverage status.

Health Net's Plan Year 2025–2026 Pharmacy Plan Assessment

As of the date of this letter, Health Net has assessed its plan year 2025 and plan year 2026 commercial small group pharmacy plans. Based on the information currently available, most Health Net pharmacy plans provide Creditable Coverage for 2026.

The Health Net small group pharmacy plans that do not provide Creditable Coverage for 2026 are listed below:

If your group has not yet made its 2025 or 2026 plan selection, please review this list again at the time of renewal.

Need to Make a Change?

If one or more of your Health Net pharmacy plans does not provide Creditable Coverage, and you would like to switch to a **creditable plan**, please contact your **Health Net Account Representative**. We're happy to help you review your options.

Please note:

Creditable Coverage status is determined based on the current plan design and Medicare Part D standards **as of the date of this letter**. Because both may change annually, employers should **review and reassess creditable status each year**, especially before Medicare's Annual Election Period or when making material plan changes.

What You Need to Do

1. Notify Your Medicare Eligible Members

You must inform your Medicare eligible employees, retirees, and dependents if their prescription drug coverage is Creditable Coverage. This notice must be provided **before Medicare's Annual Election Period**, which starts **October 15, 2025**.

CMS Model Disclosure Notices

A **Medicare Part D-eligible individual** is anyone who:

- Is entitled to Medicare Part A or enrolled in Medicare Part B, **and**
- Resides in the service area of a Medicare Part D plan.

2. Report Your Creditable Coverage Status to CMS

Employers are required to notify CMS of the Creditable Coverage status of their pharmacy plans each year. This is done by completing the **Online Disclosure to CMS Form**, available at:

This form must be submitted:

- **No later than 60 days after the start of the plan year**
- **Within 30 days of any change in creditable coverage status**
- **Within 30 days of terminating prescription drug coverage**
